The Pericles LL.M. EARN A LAW DEGREE IN MOSCOW

Pericles is a unique institution in Russia, being the only law school to offer a complete American style LL.M. degree in Moscow. In establishing the curriculum, Pericles has worked closely with American and Western European law firms and companies operating in Russia. The curriculum is designed to teach the skills and knowledge that those law firms want to see in their associates and which those companies want to see in their in-house counsel and in the law firms they retain. Thus, the main aim of the program is to make Pericles LL.M. graduates competitive for the top legal jobs in Russia. Many graduates might also be able to qualify to practice law in the United States after this degree.

The LL.M. is a second degree in law and is designed to help lawyers and future lawyers increase their job prospects upon graduation. The Pericles LL.M. is a two- to three-year program with courses offered at nights and on weekends. In order to receive an LL.M. degree, you must complete 36 units of course work, which are broken down into 7 core courses (20 units of work) that students have to take in order to graduate, and 16 units of elective course (5 to 7 courses) that allow you to concentrate on subjects that interest you. Courses are taught completely in English by Western professors, using Western textbooks and materials.

Pericles Leading Students Scholarship STUDY FOR FREE OR AT A REDUCED COST.

Pericles is offering 2 exceptional students a 100% tuition scholarship for this degree. One scholarship is reserved for a student who has participated in the Russian National Rounds of the Jessup International Moot Court Competition. The other scholarship is reserved for a student from a Russian law school located outside of Moscow or the Moscow Region, regardless of whether or not that student has participated in the Jessup. Additional 50% tuition scholarships may be available to other exceptional applicants.

This scholarship is available only for students able to begin the Pericles LL.M. program in the Fall 2011 term. All scholarships are renewable for the duration of the LL.M. program subject to satisfactory academic performance. Scholarships are not available for special study-abroad programs and do not include the cost of textbooks, or administrative fees of 5000 rubles/course.

2. WRITE AN ESSAY EXPLAINING WHY YOU THINK YOU SHOULD GET THE SCHOLARSHIP.

3. TAKE AN EXAM (ON ENGLISH AND LOGICAL SKILLS) IN MOSCOW ON JULY 12, 2013.


