Students and graduates are invited to participate in the forum.

**Working languages of the forum are Russian and English.**

**Workshops and roundtable discussions cover the following areas:**

- *The theoretical, organizational and methodological support of forensic activities;*
- *Use of special knowledge in civil and arbitration proceedings;*
- *Use of special knowledge in the criminal process;*
- *Using the expertise for dealing with administrative offenses;*

**In addition, there are master classes based on the following topics:**

- *Study of documents;*
- *Study of the written and spoken language (including linguistic, authorship identification and phonoscopic expertise);*
- *Fingerprinting;*
- *Portrait examination;*
- *The olfactory examination*

**Theses are accepted until the 6<sup>th</sup> September 2013.**

**The procedure and requirements for submitting applications for participation in the forum:**

Compress your theses and applications to RAR archive (\*.rar, the size of archived files should not exceed 3 Mb) and e-mail the archive to the organizing committee: [kep-ise@rambler.ru](mailto:kep-ise@rambler.ru) The archive should contain the application form, author's photos and theses of the article. Fill in the "Subject" field with «**Problems of using special knowledge in Russia and abroad**», the applicant's full name and university.

- 1) *An application for the participation of the student/graduate.* Should be composed in accordance with Annex number 1;
- 2) *Photograph of the author* (to be placed in the book of theses);
- 3) *Theses (article).* Should be composed with Annex number 2, the amount should not exceed five A4 pages, including name, full name, place of study, work, author's status, initials, degree and position of the scientific advisor. Text, name, status of the author and the supervisor

and the name of the work should be typed in 1.5 spacing, size 14, 2 cm margin of the page, font Times New Roman. Your name, the name of the University and the author's status (student/graduate student) are indicated in the upper right corner. The title of theses is centered in bold. Footnotes are placed by page and numbered united throughout.

Please note that one participant has the right to represent only one article at the forum.

Students and graduates who have sent applications and theses in compliance with all the requirements for registration and deadline for submission will be allowed to participate in a forum on a competitive basis.

The main selection criteria are originality of submitted materials, their relevance, and author's independence.

**The organizing committee reserves the right not to state the reasons for refusal to participate. The publication in a collection of articles is free.**
