## 1. Nomination (For nominated students)

All exchange students must be nominated by their home university. Nomination is to be received by FTU via this form:

## 2. Application

- Prepare necessary application documents and submit to [inbound@ftu.edu.vn](mailto:inbound@ftu.edu.vn)

1. **01 copy of VALID passport** (Passport must be valid beyond student's period of stay in Vietnam. Coordinator please make sure the student have their passport renewed in case the passport expires)
2. **01 enrollment certificate** issued by home university
3. **01 general medical check-up** (issued by any hospital or clinic in your home country) (must be in English)
4. **01 nomination letter** by home university (for nominated students)
5. **01 photo of English Language Certificate** (IELTS 5.5, TOEFL iBT 65 or equivalent) (Students from English native speaking countries or studying in English taught programs in home university do not have to submit English certificate).

## 3. Letter of Acceptance

Within 2 weeks after application forms are received processed, OIA will send the incoming students an acceptance letter and other important information upon arrival in Vietnam via e-mail.

---

## 4. Financial Information

### Paid to FTU

International student fee of 3.000.000 VND is to be paid before your arrival at FTU as regulated by the university.



---

### Others

Textbook, traveling cost, accommodation fee, daily living expenses and expenses for extra-curricular activities outside the program are covered by students.

---

### 5. Tuition fee

**Tuition fee is waived for nominated students** from universities which have already signed the exchange agreements with FTU.

Students from non-agreement universities or students that have exceeded the quota of students from universities with agreements shall pay tuition fee per credit to FTU according to the regulations of FTU.

Tuition fee shall be paid upon arrival depends on your selected courses:

1. **High-quality program - 90 USD/credit** -> 270 USD/course
  2. **Advanced program - 105 USD/credit** -> 315 USD/course
- Payment must be made using Vietnamese Dong
- 

### 6. Accommodation

**FTU does not offer accommodation for exchange students**, however, a housing list will be provided to students along with the Letter of Acceptance for reference.

---

### 7. Visa

**FTU will support you to get the visa one time before you arrive to study in Vietnam** (multiple entry) and will send the visa document to you **2 weeks before your Orientation day** via email. You can enter Vietnam after you receive your visa document.

You are expected to pay for your visa in Noi Bai International Airport upon arrival.

**The visa price will be around 145-155 USD**

If you enter Vietnam earlier, your visa will not be student visa and you will have to be responsible for all relating issues.

### 8. Academic transcript

**Transcripts will be sent via e-mail to student and their home university coordinator approximately three (03) months after completion of the program.** The hard-copy transcript will directly to the coordinator mailing address (as provided in the nomination form) at a later date.
